**Block Watch Report:**

Officer Curley said that there have been break-in's around us, but not in the Quarry. They have been in Brandywine and at The Homestead entrance which was a large loss and during the daytime hours. Vehicles are easy prey if they are unlocked in the driveway and items are left in them. Keep them locked and do not leave you garage remote in them, which gives access inside your home.

They have gotten complaints from residents on the rim, about kids swimming .

Solicitors have also been a complaint, so you can tell them they are not allowed in here and ask them to leave. If they appear to be suspicious to you, call the police with a description and license number if possible.

The Monclova Police dept has been moved to the back of the fire station at Albon and Monclova roads.

They have been responding to calls in the Springfield township area if they are available to help out .

**Treasurers Report;**

The balance in our account is \$36,640.53 and we received \$1700. in dues payments. Louisville Title owes \$20,256.00 in delinquent dues and \$8400 is owed by several residents. We will have to write off \$2720 due to foreclosures.

We are going to turn over a delinquency list to our attorney and he will contact everyone on the list with a letter of intent to collect the dues through the court system.
